- SGD SILLS SET IN SOLID AND FULL BED OF PORTLAND CEM MORTAR W/ FASTENERS AS SHOWN IN DETAILS
 - SILL FRAME OF ALUM. WINDOWS HELD IN PLACE BY POURED CONC. SILLS & ANCHORED IN PLACE BY EXTERIOR STUCCO, INTERIOR WIN. SILL, & FASTENERS PER DETAILS & N.O.A.
 - WIN & SGD SHALL BE TESTED PER ASTM E330-90 FOR STATIC AIR PRESSURE REQMTS. & SHOW THAT UNITS WILL MEET THE MIN.
